The hygienic, low maintenance CleanRane™ Air Spa System features 12 air jets with spring loaded check valves for back flow prevention. Unlike most other whirlpool and air spa systems, the CleanRane™ Air Spa System does not allow water to enter the air lines, which can become a breeding ground for bacteria and mold. The motor is quiet, efficient, and has a ceramic heating element that blows warm air to help maintain the water temperature and warm the surface of the tub.
